Random drawing will be conducted by **Pioneer Community Energy** on January 3, 2023. The odds of winning depend on the number of eligible entries received. The odds of an entry winning will be the same for any method of entry. All prizes will be awarded by **Pioneer Community Energy** on the following corresponding electricity bill. Limit one (1) entry per customer residence or place of business.
